

Significant challenges presented themselves during the duration of this contract, despite the changes in scope and 4-6 months of delays, the construction was completed within the original 12-month period.

**QUEENS BOROUGH HALL, QUEENS, NY -** AFG provided CM services to the NYC Department of Design and Construction for this renovation and addition of the Queens Borough Hall. Among other additions to the interior space, the project included the addition of new HVAC systems, electrical systems, boilers/chillers, four handling units and fire alarm tie-ins. Exterior renovations consisted of new limestone façade. This project is LEED Silver certified.

## HURRICANE SANDY RAPID REPAIRS EMERGENCY SERVICES, NEW YORK CITY,

**NY -** The day after Hurricane Sandy wrought havoc over New York City, AFG launched two inspection teams who worked non-stop for the next 5 days performing building assessments and site inspections at 20 different housing developments throughout Queens, the Bronx, and Brooklyn. Within 3 months AFG had successfully completed and closed out over 3,000 homes and projects.
