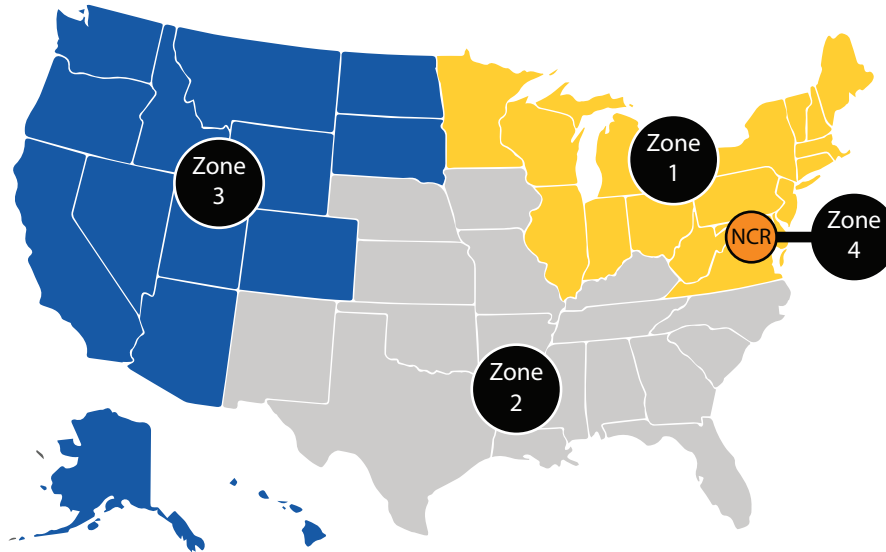




GSA Small Business BPA: An Introduction

Issue **RFQ** to all eligible BPA holders, or follow procedure for limiting sources

Select **best value quote**

Document **best value** determination and evidence of compliance with ordering procedures

Period of Performance

Base Year + 4 Option Years
